The following set of questions and answers is provided.

**Q1. Item #40: TROY Texas Power Bar AOB-2000T**

This bar has very aggressive knurling (grip). I would compare the knurling to 80 grit sandpaper. We've had to return some of these bars from health clubs because the grip was "too aggressive" for their members. TROY also makes the AOB-1500T bar with medium knurling in case you want to mix a few of these in.

A1. The City would like to keep this item as originally specified.

**Q2. Free Weights Proposal Form** Need a quantity for items 42 and 48 please

A2. The quantity for these line items is zero (0). The line items have been struck through on the revised Attachment B – Itemized Free Weights Proposal Form\_R1

Q3. Please confirm quantity for line Item number 3 - TKO Dumbbell Set 5-50#, 10 pairs, SDS Urethane 828US-A10

A3. The quantity has been changed from four (4) to one (1) on the revised Attachment B - Itemized Free Weights Proposal Form\_R1

Q4. Should the TKO Dumbbells on line items 5 - 19 be rubber or urethane coated?

A4. The dumbbell should be urethane coated. Descriptions have been updated on the revised Attachment B - Itemized Free Weights Proposal Form\_R1

Q5. Regarding the individual dumbbells on lines 5 -19, should a 45lb TKO Dumbbell be provided?

A5. No

Q6. Line items 42 and 48 have no quantity and appear to be a duplication of the TKO Collars.

Q7. Please specify grade desired for Troy Rubber Bumper Plates, line items 43 - 47

A7. Bumper plate descriptions have been updated on the revised Attachment B - Itemized Free Weights Proposal Form\_R1

Q8. Line items 49 - 60 kettlebells are listed as Troy but SKU is TKO. Which should be quoted?

A8. TKO Kettlebells should be quoted. Descriptions have been updated on the revised Attachment B - Itemized Free Weights Proposal Form\_R1

Q9. On the Excel spread sheet item number 1 (TKO rubber hex set) has a rack that is included to place dumbbells on. Our question is will this rack need to be placed as a permanent fixture bolted to the floor with lag bolts or will it be free standing?
