

Commerce City's Snow Guardians Program Application
Commerce City Code Enforcement

The Snow Guardians Program assists residents who are unable to clear public sidewalks adjacent to their property to comply with Sec. 6-2012 of the municipal code due to age, disability, or other conditions. Sec. 6-2012 states that owners are responsible for the maintenance of their property with a duty to maintain any and all unsafe sidewalks. The Snow Guardians Program assists residents who cannot shovel their sidewalks after a snowfall.

Note: The Snow Guardians Program only assists residents with clearing snow from public sidewalks in order to comply with the municipal code and does not apply to driveways, porches, or private walkways within your property. Qualifying residents may apply 48 hours prior to the projected snowfall.

_____ I understand applications will be processed as they are received and that submitting this application does not guarantee services will be available to clear my sidewalks.

_____ I understand I must submit an individual request per snow event.

_____ I understand my name and phone number will be shared to allow communication while my property is being cleared.

_____ I understand I am responsible for notifying the City of Commerce City if I no longer require assistance.
