Curt Holland Memorial Park now open for neighborhood families

Family, friends, and colleagues of the late Det. Curt Holland gathered with community members in the Villages at Buffalo Run East on Friday, June 14 for a ribbon-cutting ceremony at the new Curt Holland Memorial Park.

The pocket park broke ground just last month and is now located along Buffalo Run Drive on land provided by the Villages at Buffalo Run Property Owners Association, with support from Buffalo Ridge Metro District, FOP Lodge 19, Suncor, Commerce City, and most notably the dedication of Curt's widow Amanda and the Holland family.

The park that now bears Det. Holland's name will serve local families in the neighborhood while helping keep Curt's memory going strong in the community he himself served.



Commerce City hosts two Juneteenth events

The city's Diversity, Equity, and Inclusion Commission recognized Juneteenth in Commerce City for a second straight year with community gatherings celebrating the contributions of African Americans to our community and our nation.

– Staff received an update on proposed residential development along Tower Road. The project encompasses approximately 150 units including public amenity areas and parking. It also has potential to add new residents that will aid in the marketing of the city to prospective retailers and restaurants.

– Staff provided business retention and expansion support for an a company that provides e-commerce, cloud computing, digital streaming, and online advertising.

– Staff assisted in the planning of a ribbon cutting event for Performance Food Group's new facility in Commerce City. Mayor Steve Douglas, Economic Development staff, and company executives celebrated the completion of the project.

– Staff met with the Chamber of Commerce leadership to review, update, and streamline ribbon cutting coordination for both entities.

– Staff gave a presentation to the 2024 Leadership Commerce City class. Staff provided an overview of city statistics and demographics. After that, staff gave an overview of the Economic Development division's work areas and priorities to the class.

– Staff met with the management analyst team to review and discuss the city's fiber infrastructure strategic plan.

– Staff provided planning and support for the Catalyst Fund mural restoration project on a business located in Derby.

– Staff represented Commerce City at a site selection conference held in South Carolina. Staff was provided the opportunity to connect with site selectors working nationally and internationally in a variety of industry sectors.

– Staff represented Commerce City at the 2024 State of the Region event presented by the Adams County Regional Economic Partnership attended by representatives from surrounding municipalities and their elected representatives. Staff learned more about the trends impacting the state and region were presented by the State of Colorado's Chief Demographer.

CCPD Deploys Video Surveillance Trailers

The Commerce City Police Department is hoping you've noticed the giant trailers with lights, a mast, and a camera or two attached. They're hard to miss, and frankly that's the idea—make people think twice before committing a crime within their presence.

We've got a couple of what are essentially surveillance trailers, and we are putting them in places where we've seen an uptick in vehicle and property trespasses.

Currently, one is surveilling the popular Pioneer Park parking lot so while you're swimming or enjoying the other features there you can feel a little more confident your vehicle is safe. And if someone decides to ignore the trailer and commit a crime anyway, there's a high probability that we will be able to identify them or pull images and videos to share on social media in hopes someone from the public recognizes the culprit(s). We'll be moving these surveillance trailers from time to time and are open to suggestions on locations. Infrastructure

PW Updates

Preservation and Safety

- Pavement teams demonstrated a JCB specialized pothole machine. Multiple agencies from the Denver Metro area also attended the demonstration on the new piece of equipment. Teams showcased their talents running equipment, making asphalt repairs, while reviewing the latest asphalt equipment.



Engineering

- A project coordination meeting was held with the consultant developing the Highway 2 Corridor Study.
- Staff held a monthly utility coordination with the partnering franchise utility companies. The meeting is conducted to coordinate with the utility companies for the city's Capital Investment Program (CIP) projects as well as getting information about the utility companies planned projects in the city.
- A meeting was held with the Colorado Department of Transportation (CDOT) Bridge Division to review the 2023-2024 bridge inspections of the city's 33 bridges.
- Staff attended the weekly coordination meeting for the E-470 widening project, which extends from E. 104th Ave. to the southern city limits within Commerce City.
- Staff attended the monthly E-470 Board Meeting.
- Staff attended the Adams County Council of Governments Subregional Forum meeting.
- A monthly coordination meeting was held for the Colorado Department of Transportation (CDOT) Vasquez improvement project. The first bid package for the project will be advertised on January 17.
- Staff met with Advanced Traffic Signal Performance Measures (ATSPM) vendor to continue system configuration.

Active Permits

Parks

- This week, our Parks division was hard at work maintaining our parks and open space areas. Crews began the week by promoting cleanliness at Veterans Memorial Park and Eagle Pointe Recreation Center and pressured washed both entrances.
- Teams prepared for various events throughout the week, notably the Music in the Park event on Thursday, June 14 at Veterans Memorial Park.
- On Friday, crews assisted during the grand opening of the Curt Holland Memorial Park hosted by Commerce City Police Department.
- In between the harsh weather conditions of rain and winds, staff have had to keep up on maintenance in parks and open spaces. This week staff removed a damaged tree at Eagle Pointe Recreation Center.
- Herbicide control continued this week with various sites being sprayed for weed maintenance. A total of 250 gallons was applied at Second Creek Open Space alone, while another 200 were applied at Refuge Perimeter Trail.



Streets

- This week, our Traffic Teams had a variety of tasks to ensure safety throughout city's streets.
- Teams adjusted a total of 44 school zone flashers throughout the city to accommodate the school summer schedule.
- Crews were sent to E. 56th Avenue and Holly Street to install new signage. This sign gives awareness to drivers of the upcoming dead end.
- Teams also repaired 8 down signs throughout the city.
- Pavement teams were busy this week and began grading two lane miles of roadway on E. 112th Avenue from Tower Road to Parkside.
- Teams also completed crack seal operations in the Turnberry neighborhood and applied two tons of mastic and one ton of crack seal.
- Stormwater teams drained stormwater drains near E. 112th Avenue and Highway 85 after the storm.
- In collaboration with the Parks Division, crews cleaned a fuel spill at Olive Park with vacuum trailer.

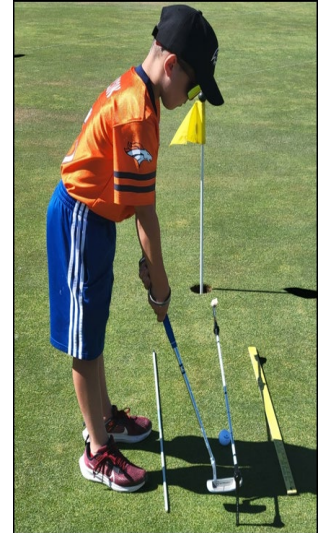
Junior Golf at Buffalo Run Golf Course

Junior Golf activities are in “full swing” at Buffalo Run with kids enjoying a variety of options to learn the game of golf. Three different programs are available to promote growth in the game:

The **PGA Junior League** program is an in-house league with staff coaches, regular practices, and team play with other facilities throughout the metro area.

First Tee is a national program that combines golf instruction with character building; areas of emphasis include goal setting, conflict resolution, appreciating diversity, managing emotions, and planning for the future.

Junior Camp includes three days of instruction on putting, short game, and full swing for kids of all ages. The student-to-teacher ratio is limited to 5 to 1 for maximum learning in a fun environment.

On Thursday, June 13, the Commerce City Cultural Council, in partnership with PRG kicked off the summer Music in the Park series at Veterans Memorial Park.
