Use legal fireworks wisely on July 3-4

PERSONAL FIREWORKS THAT ARE LEGAL UNDER STATE LAW are allowed in Commerce City until 11 p.m. ONLY on July 3 and 4 (and Dec. 31). Fire danger remains high, so please use fireworks responsibly on the allowed days, and be courteous to your neighbors – especially military veterans and those with pets.

Using personal fireworks remains prohibited on all other days and in public areas like parks and trails. Penalties for fireworks violations include fines starting at \$1,000 for a first offense and \$2,000 for a second.

To report a fireworks violation, call the non-emergency dispatch line at 303-288-1535 or visit c3gov.com/Police. Do not call 911 to report fireworks violations, since this could slow down response times for life-threatening emergencies.

Keeping of backyard chickens and bees officially allowed starting Aug. 2

SINCE COMMERCE CITY VOTERS APPROVED the backyard keeping of chickens and bees (but not ducks) in the 2023 election, city staff has been busy researching and drafting regulations to govern this new measure. Regulations were approved by City Council at the June 3 meeting and officially go into effect 60 days later to allow time for notifications and education.

Residents need to acquire a permit to keep chickens or bees and can apply for one after Aug. 2. Keep in mind that local HOA or metro district rules


could supersede city laws, so check your local rules before setting up any coops or hives once the regulations take effect. If you want to keep chickens or bees in your backyard, you'll need to get a permit through the city's eTRAKiT portal. This includes submitting a property diagram showing where you will keep them. Separate permits are needed for chickens and bees, each costing \$70 and lasting as long as you keep the animals, unless you stop for 12 months. These permits are specific to you and your property and can't be transferred. Remember, your HOA and metro district rules still apply.

For chickens, no roosters are allowed. They need to be kept in an outdoor enclosure or coop, and not in the front yard, with the same setbacks as your house. For bees, you can only have non-aggressive bees, with a maximum of two hives per property. Each hive cannot be taller than five feet or larger than 20 cubic feet. Flyways should ensure bees fly at least six feet above the ground over property lines, and hives must be built to minimize human or animal contact.

Thank you for being an integral part of our community. Together, we will keep moving forward, building a brighter future for all.


CDOT seeking public feedback on I-25 improvements starting at I-270 interchange


The construction on Newport St is expected to be completed by the end of July. The second part of the project will focus on the area of Oneida St from E 74th Ave to Highway 2. Work on Oneida St is expected to begin by July 31 and be completed by October 2023.

The project is essential to improving and maintaining the District water system and will enhance fire protection and water service reliability in the area. Customers will be notified of any scheduled service outages during the project with a minimum of 48 hours prior to interruption of service. During the construction there will be temporary partial road closures, please follow any work zone traffic control in place.

RMA Celebrates Retiring Program Manager

Charlie Scharmann is retiring as Army program manager at the Rocky Mountain Arsenal (RMA) at the end of June. Scott Greene, an RMA environmental engineer with more than 30 years of technical, program management and staff supervisory experience, will serve as acting program manager until a full-time leader is hired.

Scharmann began his service to the RMA program while with the U.S. Army Toxic and Hazardous Materials Agency at Aberdeen Proving Ground in Maryland. After transferring to Colorado, he became the RMA program manager in 2000 and assumed leadership of the \$2.1 billion environmental

remediation program. In this role, he ensured environmental cleanup goals were met and built a nationally recognized safety program and performance record.

"It's been a privilege to partner with the community, RMA and Refuge staff, and regulatory agencies to fulfill the vision for this site," he said. "I'm proud of what we have accomplished together and of the natural space we have created for the community to enjoy."

Community Questions

Q: Is RMA a source of air pollution for the surrounding community?

A: No. The environmental remediation being conducted at RMA does not create air pollution. The groundwater treatment facilities do not produce air emissions, nor does the monitoring and maintenance of the two on-site landfills and two waste consolidation areas.

Although the U.S. Fish and Wildlife Service conducts occasional prescribed burns to maintain healthy vegetation and reduce wildfire risks, the timing of the burns is coordinated with the Colorado Department of Public Health and the Environment to ensure air quality will not be negatively affected.

Prior to the completion of the surface environmental cleanup in 2010, the Army followed strict dust control protocols and

operated an air monitoring program to ensure on-site activities posed no air pollution risks to the surrounding community. The data showed that air quality at RMA was consistently better than in the greater Denver metro area.




Army Planning New Consolidated Groundwater Treatment Plant

The Army is planning to construct a modernized groundwater treatment plant at RMA to replace two existing treatment plants that are over 40 years old. The new system will improve the efficiency of groundwater treatment and allow for additional treatment processes in the future, if needed.

Construction is expected to begin in 2026, and more information about the plant's design will be published in future newsletters and on the RMA website. The new plant will be located just east of RMA's existing Northwest Boundary Groundwater Treatment System near the intersection of Highway 2 and 88th Avenue (see map at right).

The new plant will consolidate groundwater treatment from the North and Northwest Boundary Containment Systems into one facility. The existing



systems, which have been operating for 40-43 years, are nearing the end of their design lives and are due for modernization. Groundwater will continue to be pumped from the current groundwater extraction wells, and reinjected after treatment into the existing recharge trenches or wells (i.e., there will be no change in extraction or reinjection locations).

Army Selects Primary Operation & Maintenance Contractor

Following a competitive process, the Army has awarded a nine-year contract to Navarro Research and Engineering, Inc. (Navarro) to support the ongoing operation and maintenance of the environmental cleanup program at RMA.

Navarro has supported the Army at RMA since 2012 and has established an exceptional safety and performance record. Under this follow-on contract, Navarro will continue serving as the Army's primary contractor. This work will include performing operation and maintenance of the remedy facilities, as well as supporting groundwater and surface water monitoring, quality

management, regulatory compliance and more.

Although most of the former Rocky Mountain Arsenal has been transformed into a national wildlife refuge, the Army will permanently own about 1,100 acres at the site. Those lands contain groundwater treatment facilities, as well as two on-site landfills and two waste consolidation areas.

In partnership with the regulatory agencies, the Army operates and maintains those facilities to ensure the environmental cleanup continues to perform as designed and remains protective of public health and the environment.
